The statutes of the association apply to membership. The membership fee shall be in accordance with the respective membership fee regulations. The statutes and membership fee regulations are available for inspection at the office.

According to the currently valid statutes, resignation from the TSC Eintracht can only be made with a notice period of 6 weeks to 30.06. and 31.12. of a year (receipt at the office by 19 May or 19 November). The declaration of resignation must be made in text form by letter or e-mail and requires proof of timely delivery (e.g. registered mail receipt or confirmation of receipt) to be legally effective.

In accordance with the authorisation below, membership fees shall in principle only be collected by direct debit. If the account does not have the required cover, the account-holding bank shall not be obliged to honour the payment. The direct debit authorisation is granted upon revocation at any time. The obligation to pay does not expire through tacit absence from the training sessions.

In the event of the registration of a minor child, I, as the legal representative, assume the directly enforceable guarantee for the payment of the membership fees due until the child reaches the age of majority and waive the defence of anticipatory action.

According to the valid statutes of our association, membership fees are levied on members to cover expenses. The membership fee is not a payment, i.e. the fee is not levied for the provision of a service (performance and consideration), but for membership in the association. Upon joining the association and paying the respective membership fee and additional fee, each member is entitled to use the respective offers of the association, provided that there are free places in the groups. There is no right to reimbursement for cancelled sports sessions.

The TSC Eintracht regularly informs about news and current activities of the club via its club magazine and the e-mail newsletter. By becoming a member of the club, you are automatically included in the distribution list. Consent can be revoked at any time via info@tsc-eintracht-dortmund.de.
